₩Job Displacement

- AI will automate millions of jobs across nearly every industry
- Without proactive action, workers will be left behind

Data Exploitation

- Your behavior, identity, and voice are being harvested to train AI
- Consent is rarely informed, and compensation is nonexistent

Tenvironmental Devastation

- Massive data centers consume more energy than entire cities
- Water is diverted for cooling; emissions spike with every AI model

An Democratic Decay

- Misinformation spreads faster with generative tools
- Surveillance and algorithmic control erode autonomy

WHAT YOU CAN DO

As a Citizen

- **Educate**: Use this toolkit to hold a community meeting, print flyers, or host a screening of AI documentaries
- **Resist**: Opt for open-source tools; deny consent to data-mining platforms; use privacy browsers and VPNs
- Support: Mutual aid groups, worker co-ops, and local journalism

As a Student or Educator

- Add AI ethics and data rights to curricula
- Encourage cross-generational learning about tech power
- Host teach-ins or skillshares on privacy and resistance

As a Local/State/Federal Official

- · Advocate for a pause on large-scale AI deployments
- Introduce bills supporting UBI, worker retraining, and ethical AI
- Protect community internet infrastructure from corporate monopolies

As a Consumer

- Switch browsers: Use Brave, Firefox, or Tor
- Search ethically: Try Ecosia or DuckDuckGo
- Buy mindfully: Support companies committed to transparency and labor rights

VOTE WITH YOUR ATTENTION

- Avoid engagement with AI-generated disinformation
- Don't feed the algorithm: resist doomscrolling
- Share resources like this one. Start conversations.

SPOLICY PRIORITIES

1. Regulate Big Tech

- · Ban non-consensual data scraping
- Require environmental disclosures from AI companies

2. Guarantee Economic Safety Nets

- Push for **Universal Basic Income** (UBI)
- Fund large-scale reskilling programs

3. Establish AI Rights Frameworks

- Right to explanation
- Right to be forgotten
- Right to opt out
